If accepted for membership, I hereby agree to pay the Club, within one (1) week of acceptance, the full membership deposit or initiation fee as applicable, or alternatively, execute a contract for financing the deposit with the club. I further agree to pay membership dues as billed in accordance with the Club schedule of dues and fees (which is subject to periodic revision) for the category of membership selected. The amount of dues currently for each membership category is described on the schedule above.

#### LEGEND PLATINUM AND SOCIAL MEMBERSHIPS

The Membership Fee paid for a Legend Platinum or Social Membership is not refundable.

#### LEGEND GOLF and SPORTS MEMBERSHIPS

Upon approval of this Application, the Club promises to pay to the undersigned Legend Golf Category or Sport Category Membership applicant at the Club the "Membership Deposit" (as hereinafter defined) in lawful money of the United States of America, payable in one (1) installment on the anniversary date thirty (30) years from the date of approval of this Application for Membership by the Club (the "Maturity Date") or earlier as provided in this Application. The Membership Deposit shall not bear interest.

A Legend Golf Category or Sport Category Member who resigns from the Club will be repaid the membership deposit actually paid (the "Membership Deposit") within thirty (30) days after the membership has been reissued by the Club to a new member. Prior to the initial sale of all the Legend Golf or Sports Memberships, every third Legend Golf or Sports Membership issued, when there is a membership on the waiting list, will be a resigned membership from the waiting list (the other two Memberships being from the Club's unissued Legend Golf or Sports Memberships). After initial sale of all Legend Golf or Sports Memberships, each Membership issued will be a resigned Legend Golf or Sports Membership.

- **36 Month Vesting Plan of Refundable Membership Deposits.** Legend Golf Category Memberships (Legend Golf, Legend Non Resident, Legend Jr. Executive, Legend Legacy) and Legend Sport Category Memberships are 100% refundable upon the three year anniversary date of the accepted and approved membership application. Vesting schedule is as follows:
 

0-12 months from application date	0% refundable
12-24 months from application date	33% refundable
24-36 months from application date	66% refundable
36 months after application date	100% refundable

Any portion of the deposit not vested and not refunded will be retained by the club as a non refundable initiation fee. If a membership is placed on the resignation list prior to its maturity date, deposit vesting will cease at that time.

A Legend Golf Category Membership (Legend Founder, Legend Golf, Legend Non Resident, Legend Jr. Executive, Legend Legacy) or Legend Sports Category Membership (Legend Founder Sport, Legend Sport) terminated by the Club for disciplinary cause shall be deemed resigned and the Membership Deposit shall be refunded upon reissuance of the membership.

The Club agrees to refund the Legend Golf Category Membership (Legend Founder, Legend Golf, Legend Non Resident, Legend Jr. Executive, Legend Legacy) or Sport Category Membership (Legend Founder Sport, Legend Sport) Deposit within thirty (30) days after receipt of written notice of death of the member and a request for a refund.

The obligation to repay the Membership Deposit shall be subject to set-off for all amounts due under the Membership Plan and Rules and Regulations, which remain unpaid on the Maturity Date or earlier repayment of the Membership Deposit.

## GENERAL PROVISIONS

- If the membership is terminated without cause by the Club for any reason the Membership Deposit will be repaid to the member within thirty (30) days.
- Membership is contingent upon approval by the Club, which approval shall be at its discretion.
- The Membership Deposit is subject to any special discounts that may be in effect at the time.
- Dues, as well as food and beverage minimums, are annual commitments to the club and resignation during the year does not absolve the member from these obligations. A resigning member shall remain liable in full for all dues, food and beverage minimums and charges through December 31 of that year, even if the resigning member has failed to use the Facilities. All resignations must be in writing and sent by certified United States Mail at least thirty (30) days prior to the effective date of resignation. Resignations will not be accepted until all financial obligations are settled in full.
- The Membership Deposit must be fully paid in order to be placed on the resignation list and therefore eligible to receive a refund of the Membership Deposit.
- Payment of social dues and an account in good standing is required to maintain a position on a resignation list.
- No resigned member shall be considered for reinstatement or new membership until five (5) years have expired from the date of the resignation.
- Application for membership implies consent for The Club to use any member of your families likeness for promotional or directory purposes
- **Payment of dues, fees and charges:**

I hereby acknowledge that all dues, fees and charges for food, beverage, merchandise and services at the Club, together with any applicable taxes or similar charges that are not paid in cash, if cash payments are permitted, will be billed on a monthly basis. Any bill that remains unpaid for more than thirty (30) days after billing date thereafter WILL be increased by 2.5% and charged to my credit card. I authorize any and all charges (including membership dues and fees), incurred on my account with the Club and unpaid within 30 days to be charged to the credit card listed below.
